

Submitting Manuscripts to JEH

Please submit your original contribution (not published in any other journal or as any other type of publication, and not simultaneously submitted elsewhere) as an electronic file/e-mail attachment to BCW3@columbia.edu. You may include as separate attachments any figures in pdf file format (Adobe Acrobat).

All published manuscripts in the JEH, including those that first appear at JEHonline.org, may not be published elsewhere—unless permission is granted by the publisher, StarSpirit Press (www.starspirit.com). Contact the Editor-in-Chief for inquiries in this regard at BCW3@columbia.edu.

Acceptable manuscript length varies considerably, depending upon the content and quality of the submission. General guidelines are to submit a manuscript between 15 to 30 pages in length, while pieces as long as 40 pages may be included. All manuscripts should be double-spaced and include a title page, abstract (no more than 190 words), references, figures, and tables consistent with the *Publication Manual of the American Psychological Association* (5th ed.). This manual should be consulted for information on typical journal article, table, figure, and reference formats, as well as for guidelines on obtaining permissions.

The JEH Release and Publication Schedule

JEH will initially start as a biannual online publication, with this first issue released in fall 2008. Eventually, the JEH will move toward a three time per year online release schedule, reflecting special theme issues.

An inclusive end of year volume will be printed annually and distributed (StarSpirit Press, Philadelphia, PA) to those libraries, organizations, and individuals who order copies in advance via request at www.starspirit.com.
